1.2.2007	Mr. Raghuraman and the Chairman of NAWAD Council Er.A.C.Kamaraj met the Ambassadar, Netherland, Mr. Eric. F. Ch. Niche at New Delhi on Feb.1st 2007. Mr. Theo. J.J. Groothuizen, Councellar for Science and Technology and Ms. Maya Acharya, Senior Advisor Trade were also present in the meeting. Er. V.K. Gupta, former Secretary, Institution of Engineers (India) New Delhi State Unit and a member of our expert team also joined us. We presented the NWP. The Ambassadar took keen interest and assured that their Government would cooperate with our Government

and as well as with our team to take the project further on commercial basis. Mr. Theo Groothuizen complemented our proposal greatly.

Appointment with Netherland Ambassador at New Delhi. Met Netherland Ambassador Mr. Eric, F.Ch., Niche at Netherland Embassy New Delhi at 3 P.M.

Er. Raghuraman, who arranged the appointment and who has served in Netherland for over two decades was with us. Er. V.K. Gupta and his friend also joined us. Mr. Theo J.T. Groothuzen, Consultant for Science and Technology of the Embassy and Ms. Maya Acharya, Senior Advisor Trade were also present in the meeting

We gave the presentation of National Waterways Project (NWP). The Ambassador and others took very keen interest in the Project. Science and Technology Councilor, Mr. Groohuzen remarked that this is going to be the first of this kind in the whole world.

Mr. Raguraman wanted some Dutch Co. to endorse this project . The Meeting lasted for nearly 2 hours.

We also met Mr. Krishnan Veerappan at Hotel Regency. He advised us that we should take this project on Commercial line and that too fast. He said that persons like TATA who is not only having commercial interest but also takes National interest can be approached to see the commercial viability in this project.

We also met Mr. Rajinder KAAZANCHI, CEO of Royal Harboring Consultant and Rushi Crokshi of Royal Netherlands Embassy at Hotel Regency. Gave a Presentation of National Waterways Project (NWP).

Later in the evening met Mr. P.Venkataraman Consultant and friend of Mr.Raghuraman at Hotel Oberai. He took us to Mr. Ramamurthy, Former Indian Institute of Technology (IIT) Professor and Former Secretary Science and Technology. We met Mr. Ramamurthy at his residence. We discussed National Waterways Project (NWP) in detail and also gave a presentation.

2.1.2007

Met Mr.Vora, Assistant Commissioner, MOWR. I Explained to Mr. Vora that National Waterways Project(NWP) is not similar to Captain Dastur project. Even if they look similar, there are many and many differences. All proposal either NWDA or NWP when they are on India Map, looks is similar, but you must see deeply to see the difference.

Vora said "We are already with NWDA Proposal and we can not switch over to National Waterways Project (NWP) because then the whole Project get a change. I told him that NWDA proposal is not accepted by many States. He said "Yes. but we have spent a lot. We cannot look into alternative.

I said "Then why Task Force invited alternate proposal?. Is it a fun? He said "No, I cannot say"

I told him "what you have spent on Inter Linking of Rivers is a small amount compared to the cost of the project. It is better to go for an alternate economical proposal. He does not seem to budge. Finally he asked how the water can flow without external energy in both direction? A basic question, (How this person will accept our proposal?) However I explained the working

I told Mr. Vora that in the Technical Workshop, the Central Water Commission (CWC) Chairman, the highest officer and the Member wanted to have more study in National Waterways Project(NWP). He said that they said in a different context. Who will give Money?

These people are spending crores of public money on a project not wanted by States.

But they will not fund NWP, which is welcomed by almost all the States.

3.2.2007

Mr. Raguraman, Mr.P.Venkataraman and myself met Minister of State Mr.Choran at his residence. The Minister spent more than half an hour with

	us discussing the project. He is basically an Electrical Engineer. He advised us to meet the Secretary, Ministry of Water Resources (MOWR) and also Mr. Ramasamy Iyer Former Secretary, MOWR
5.2.2007	Mr.Raghuraman and myself went to Vignan Bhavan and met Dr. V.Krishnamurthy. We explained to him National Waterways Project. He was eager to know more about Two-Way flow. I explained. He told us that he will come to Chennai next week for 10days and that we can meet then and discuss the project more since he will have more time there. Than met Mr. RaviSankar Supreme Court lawyer at 179 South Avenue and discussed the developments. There was really no development. Every body says the project is good and nothing moves forward. Whether it is the Planning Commission, Parliamentary Affairs Committee (PAC) on Water Resources (WR) or the officials in MOWR. He suggested that we can go to Supreme Court as impleader or as Intervention. Mr. Gurumurthy, advocate from Bangalore rang me to day and advised to go to Supreme Court as impleader. We also told President that i.e.corporates, like TATA, who takes in Nation's Pride, sees this project for development on a Commercial viability, it will move fast. He accepted. 14.2.2007	Mr. Sunderasan and myself met Prof Naganathan, Vice Chairman, Tamilnadu Planning Commission. He enquired about our meeting with Chief Secretary Mr. L.K. Tripathy I.A.S. Then he discussed Tamilnadu Waterways Project. He said that Tamilnadu Waterways Project is a very good Project and he even went to the extent of explaining how to plan its implementation. In the evening met the Chief Secretary Mr. L.K. Tripathy I.A.S. He said that
	he spoke to his counterpart in Andhra and is expecting a reply. I told him

	that it is O.K. to approach Andhra but Tamilnadu Waterways Project is independent and is meant for flood disaster management and conserve flood water in Tamilnadu.

Beside praising the book, I brought out the salient features of our project and its benefit. I explained how Vaigai will become a perennial river after the completion of National Waterways Project (NWP).
25.2.2007	Had a meeting of at office and discussed further works on National Waterways Project (NWP)

It was decided to create awareness among public on National Waterways Project (NWP) through out the State during the anniversary function, which falls on 11th March.

Along with Er.V. Kasi, attended South Asia Water Forum Round Table Conference at 70 Lodi Estate, New Delhi. Hon'ble Minister of Water Resources inaugurated the Conference. Parliamentary Affairs Committee for Water Resources Shri. Sambasiva Rao, M.P., Shri. K.S. Rao, M.P. Shri Robert M.P., Ramasamy Iyer, Former Secretary Water Resources Shri Subash Chander, Former Indian Institute of Technology (IIT) professor, Mr. David Grey, Senior Water Advisor, World Bank, Mr.Sekar Former Advisor, Planning Commission, and many eminent persons attended the meeting. 25.3.2007	Mr. Dubey S.B, Former Chairman, arranged a meeting in the Institution of Engineers India (IEI). The meeting started at 5.30pm and went on till 8.00pm. There were many IEI members particularly Former Chief Engineer of Irrigation Mr. Lal Sharma, Mr. Kumar Verma, and others. We presented BWP and it was followed by discussion. The members felt that there is a lot of water in North Bihar and that we must plan to bring water from North to South Bihar.

26.3.2007

The Bihar Government invited us (copy of their letter dated 12-03-2007 enclosed) to present the project for Networking of Rivers (NWR) within Bihar State. Accordingly the project was presented in the State Investment Promotion Board on 26-03-2007. Mr. Vijayaragavan, Industrial Commissioner, Bihar had arranged for our presentation in the State investment Promotion Board on March 26th 2007 in the presence of the Commissioner Development Board, Mr. Jaya Mohanpillai, I.A.S., the Commissioners for irrigation, Industries, Power and other Chief Engineers. The Commissioner was convinced of this proposal and said we can take up study of the Bihar Waterways Project

March 26th 2007: FN

We had a preliminary meeting with Mr. S.Vijayaraghavan, Commissioner Industrial Development. It was attended by the Director of Industries and Deputy Directors both by name S.P.Singh.

The meeting started at 9.30am and lasted for over an hour.

We discussed how the rivers in Bihar can be linked by our Waterways. Mr. Vijayaraghavan asked me as to how I ensure two way flow. I explained with two tumbler and a horizontal tube. He understood and he went through all the press release about our project and even took photo copies of the same.

March 26th 2007 AN:

We, Er. V.Kasi and myself were asked to present Bihar Waterways Project (BWP) in the State Investment Promotion Board.

The meeting started at 4.30 pm and continued for over one hour.

The meeting was presided by Mr.R.Jeyamohanpillai., I.A.S., Development Commissioner, Government of Bihar and was attended by Commissioner Industrial Development Mr.S. Vijayaraghavan, Commissioner for Irrigation Mr.Ashok Kumar Sinha, other Secretaries, Chief Engineer and others.

We presented BWP in the meeting. The irrigation commissioner asked how to control flood in North Bihar, I told him North Bihar is more flat and to control flood in Bihar it would be advisable to tackle the flood from Nepal which is at a higher level. He said that it will be difficult to make Nepal to accept.

I suggested we can form a Networking of Rivers in Bihar in the North but then it will be very costly.

The Development Commissioner who presided over the meeting advised us to have one more meeting preferably the next day and to which we both accepted.

Then met Mr. S.Vijayaraghavan Commissioner, at his office and gave the letter for taking up TEFS for Bihar.

27.3.2007

Had a meeting with Irrigation Commissioner at Bihar Secretariat. The meeting was attended by the Chief Engineers of Irrigation of Bihar Government. Er. V. Kasi also attended. The commissioner asked us to explain the BWP, which I did shortly. The two-way flow was also explained. The Chief Engineer were particular to bring water from North Bihar to South Bihar. explained that it is possible to bring water at a higher level from Nepal to which they did not accept. Then I explained that it is possible to bring water from West Bengal to Bihar Rivers (Flowing from West Bengal to Bihar). They said that we have to pump water once it is brought near Ganga. I explained that pumping is not necessary and we can bring water from North to South by gravity where we take at a higher level through pipes and siphon system will work. Further pumping such huge quantity will not be economical. The commissioner and others accepted this proposal.

28.3.2007	Then their problem was storing the water thus brought. I told them that the water can be stored in the Balancing Waterways (BWW). They first did not agree. After explaining the section (200m length & 25m depth) and the capacity, they accepted. I told then that the waterways will be able to store more than the biggest dam in Bihar.Commissioner discussed more on the section & asked what will be the cutting. One of the Chief Engineer seeing our section said that it will have 15 m cutting. Commissioner immediately said "It is O.K." The Commissioner also said that South Bihar border is not thickly populated and more or less forest. So there should not be any difficulty to have the Bihar waterways in South Bihar. I told that balance of cutting and filling in adopted for economy. "When we asked the Commissioner what proposal they have for storing water, he said that he has asked consultants to give proposals and they are yet to receive. The Commissioner at the end of the meeting said that we can study this Proposal further. Received a call from Prof. Saifuddin Soz, Hon'ble Minister for Water
26.3.2007	Resources. I was then at Chennai. Minister told me, "Prof. Kamaraj I want to discuss with you. Can you meet me?" I said that I will definitely meet him. Then he continued. "There are some problem in Inter Linking River (ILR). I want to discuss with you and sort it out "I said I will meet the Minister. Met Dr. K. Karunakaran, Director CWS and Dr. G. Ravikumar Assistant Professor and discussed making a physical model for Tamilnadu Waterways Project (TWP). Also discussed data collection with Er. Sundaresan and Mr. Prabhu.

The Proposed meeting with Hon'ble Minister for Water Resource (WR) was also discussed.

27.7.2007	We also received a communication from the Government of Bihar as per the Letter No.2558 dated 21-09-2007 informing us that further discussion on this is being taken up in the State Investment Promotion Board (copy enclosed)

7.1.2008	The Vice-Chairman, Tamilnadu State Planning Commission asked us to present the project for sustainable water management through flood water management on Oct.18 th 2007 through Mrs. Girija Vaidyanathan, Member Secretary. Accordingly, the Tamilnadu Waterways Project for flood Management within Tamilnadu was presented on Oct. 18 th 2007 in the presence of Dr. M. Naganathan, Vice-Chairman State Planning Commission, Members, Planning Commission, Secretary, PWD and other Engineers. The State Planning Commission Tamilnadu has informed to pursue the matter further. We met Mr. Theo .J .J. Grothuizen, Technical advisor of Netherlands
7.1.2000	Embassy on Jan 7 th 2008 at New Delhi. Er. K. Easan also accompanied. He assured that firms from Netherlands will participate in the implementation of Ganga-Kumari National Waterways Project (NWP).
8.1.2008	Attended Expert Committee meeting on Inter Linking of Rivers (ILR) (08/01/08) Attended Expert Committee meeting on Inter Linking of Rivers (ILR) on Jan 8 th 2008 at Shram Shakthi Bhavan, New Delhi. The Preparation of Detailed Project Report (DPR) of Ken-Betwa Link was discussed. The clearance from Supreme Court for Pennar Tiger Reserve Forest area is awaited. I stressed the point that delaying ILR is causing a loss of over 1, 00, 000 Cr every year (By way of increase in cost alone). We are at the preparation of DPR for only one link and that we are unable to move on to the next. The preference of the present Government is to take Penisular link and the Hon'ble minister says that they can move to DPR for other links only after getting the consent from other States and the same is awaited. But many States are reluctant to accept ILR proposal by NWDA. I also made it clear that many States accept NWP as an alternative to ILR. Mr. Vijayaragavan, Industrial Commissioner, Bihar had arranged for our presentation in the State investment Promotion Board on March 26th 2007 in the presence of the Commissioner Development Board, Mr. Jaya Mohanpillai, I.A.S., the Commissioners for irrigation, Industries, Power and other Chief Engineers. The Commissioner was convinced of this proposal and said we can take up study of the Bihar Waterways Project

March 26th 2007: FN

We had a preliminary meeting with Mr. S.Vijayaraghavan, Commissioner Industrial Development. It was attended by the Director of Industries and Deputy Directors both by name S.P.Singh.

The meeting started at 9.30am and lasted for over an hour.

We discussed how the rivers in Bihar can be linked by our Waterways. Mr. Vijayaraghavan asked me as to how I ensure two way flow. I explained with two tumbler and a horizontal tube. He understood and he went through all the press release about our project and even took photo copies of the same.

March 26th 2007 AN:

We, Er. V.Kasi and myself were asked to present Bihar Waterways Project (BWP) in the State Investment Promotion Board.

The meeting started at 4.30 pm and continued for over one hour.

The meeting was presided by Mr.R.Jeyamohanpillai., I.A.S., Development Commissioner, Government of Bihar and was attended by Commissioner Industrial Development Mr.S. Vijayaraghavan, Commissioner for Irrigation Mr.Ashok Kumar Sinha, other Secretaries, Chief Engineer and others.

We presented BWP in the meeting. The irrigation commissioner asked how to control flood in North Bihar, I told him North Bihar is more flat and to control flood in Bihar it would be advisable to tackle the flood from Nepal which is at a higher level. He said that it will be difficult to make Nepal to accept.

I suggested we can form a Networking of Rivers in Bihar in the North but then it will be very costly.

The Development Commissioner who presided over the meeting advised us to have one more meeting preferably the next day and to which we both accepted.

Then met Mr. S.Vijayaraghavan Commissioner, at his office and gave the letter for taking up TEFS for Bihar.

27.3.2007

Had a meeting with Irrigation Commissioner at Bihar Secretariat. The meeting was attended by the Chief Engineers of Irrigation of Bihar Government. Er. V. Kasi also attended. The commissioner asked us to explain the BWP, which I did shortly. The two-way flow was also explained. The Chief Engineer were particular to bring water from North Bihar to South Bihar. explained that it is possible to bring water at a higher level from Nepal to which they did not accept. Then I explained that it is possible to bring water from West Bengal to Bihar Rivers (Flowing from West Bengal to Bihar). They said that we have to pump water once it is brought near Ganga. I explained that pumping is not necessary and we can bring water from North to South by gravity where we take at a higher level through pipes and siphon system will work. Further pumping such huge quantity will not be economical. The commissioner and others accepted this proposal.

Then their problem was storing the water thus brought. I told them that the water can be stored in the Balancing Waterways (BWW). They first did not agree. After explaining the section (200m length & 25m depth) and the capacity, they accepted. I told then that the waterways will be able to store more than the biggest dam in Bihar.Commissioner discussed more on the section & asked what will be the cutting. One of the Chief Engineer seeing our section said that it will have 15 m cutting. Commissioner immediately said "It is O.K. "The Commissioner also said that South Bihar border is not thickly populated and more or less forest. So there should not be any difficulty to have the Bihar waterways in South Bihar. I told that balance of cutting and filling in adopted for economy. "When we asked the Commissioner what proposal they have for storing water, he said that he has asked consultants to give proposals and they are yet to receive. The Commissioner at the end of the meeting said that we can study
this Proposal further. Received a call from Prof. Saifuddin Soz, Hon'ble Minister for Water Resources. I was then at Chennai. Minister told me, "Prof. Kamaraj I want to discuss with you. Can you meet me?" I said that I will definitely meet him. Then he continued. "There are some problem in Inter Linking River (ILR). I want to discuss with you and sort it out "I said I will meet the Minister. Met Dr. K. Karunakaran, Director CWS and Dr. G. Ravikumar Assistant Professor and discussed making a physical model for Tamilnadu Waterways Project (TWP).
Also discussed data collection with Er. Sundaresan and Mr. Prabhu. Presided over the core Committee meeting of NAWAD Council. 8) Er. V. Kasi, Former Chief Town Planning Officer, Madurai 9) Er.M. Subramaniam, Chennai 10) Er.Raghu Raman, Chennai 11) Er. Ramakrishnan, Chennai 12) Er.Sundaresan, Chennai. 13) Thirumathi Rajeswari, Chennai. 14) Er. M. Sadasivam, Chennai attended. Er. Periyasamy and Er. T.T.Kesavan expressed there inability to attend. The activites of the Council were discussed. It was proposed to concentrate the projects in Tamilnadu, Bihar & Andhra. The Proposed meeting with Hon'ble Minister for Water Resource (WR) was also discussed.
The Hon'ble Minister for Water Resources invited me for a discussion on ILR in general and NWP in particular. Accordingly I met the Hon'ble Minister for Water Resources, Government of India on April 17 th 2007 and had a detailed discussion. Also met the Hon'ble Minister of State for Planning Commission, Government of India and had discussion on the same day. The Hon'ble Minister stressed that we must accelerate the process of ILR.
Er. A. C. Kamaraj and Er. V. Kasi went to New Delhi and met the Minister for Water Resources (WR) Prof. Saifuddin Soz , on April 28 th 2007 and discussed NWP. The Minister told us "I am not against your proposal. Mr. Suresh Prabhu has written highly about your proposal. We can take up the study of the NWP with the Planning Commission as Nodal Agency" We also received a communication from the Government of Bihar as per the Letter No.2558 dated 21-09-2007 informing us that further discussion on this is being taken up in the State Investment Promotion Board (copy enclosed)

7.1.2008	The Vice-Chairman, Tamilnadu State Planning Commission asked us to present the project for sustainable water management through flood water management on Oct.18 th 2007 through Mrs. Girija Vaidyanathan, Member Secretary. Accordingly, the Tamilnadu Waterways Project for flood Management within Tamilnadu was presented on Oct. 18 th 2007 in the presence of Dr. M. Naganathan, Vice-Chairman State Planning Commission, Members, Planning Commission, Secretary, PWD and other Engineers. The State Planning Commission Tamilnadu has informed to pursue the matter further. We met Mr. Theo .J .J. Grothuizen, Technical advisor of Netherlands
7.1.2008	Embassy on Jan 7 th 2008 at New Delhi. Er. K. Easan also accompanied. He assured that firms from Netherlands will participate in the implementation of Ganga-Kumari National Waterways Project (NWP).
8.1.2008	Attended Expert Committee meeting on Inter Linking of Rivers (ILR) (08/01/08) Attended Expert Committee meeting on Inter Linking of Rivers (ILR) on Jan 8 th 2008 at Shram Shakthi Bhavan, New Delhi. The Preparation of Detailed Project Report (DPR) of Ken-Betwa Link was discussed. The clearance from Supreme Court for Pennar Tiger Reserve Forest area is awaited. I stressed the point that delaying ILR is causing a loss of over 1, 00, 000 Cr every year (By way of increase in cost alone). We are at the preparation of DPR for only one link and that we are unable to move on to the next. The preference of the present Government is to take Penisular link and the Hon'ble minister says that they can move to DPR for other links only after getting the consent from other States and the same is awaited. But many States are reluctant to accept ILR proposal by NWDA. I also made it clear that many States accept NWP as an alternative to ILR. We met the Government of Bihar, Tamilnadu, Karnataka, Kerala and Andhra Pradesh etc., These States are accepting Ganga-Kumari National Waterways Project (NWP) for implementing in their States. Air vice Marshall Narayanan explained his interaction with University of Michigan, USA and informed that the Experts there were thrilled at our project and showed keen interest.

Met the Hon'ble Minister for Irrigation, Karnataka on 23rd July and again on 24th evening and had a detailed discussion regarding Karnataka Waterways Project (KWP). Hon'ble Minister showed keen interest on KWP as it generates enormous hydro power and provides drinking water to many millions of people. Further, this project can also be taken up under Build, Own, Operate and Transfer (B.O.O.T). Since Assembly elections were going on, the Hon'ble Minister assured to invite the Chairman and to have detailed discussion on Project at the end of the month.

Met Justice Shivraj Patil on July 23rd 2009 at his residence and explained the developments in Karnataka.

30.7.2009

Met **Hon'ble Minister Shri. Jaipal Reddy** who is a good friend of our Chairman at his residence New Delhi on 30th July 2009 and explained about the project and also stressed that the project can be taken up under B.O.O.T. The Minster assured to do everything in his capacity to realize this project

31.7.2009

Attended the 7th Expert committee meeting on July 31st 2009. It was explained in the meeting that the CWC has reviewed the NWP proposal many imes. Our NWP can be sent with more technical details only after taking up reasibility study for one segment based on NWP. Mr.Sen, Expert committee nember and Former member CWC also supported our project and also nsisted that the Feasibility study should be taken based on NWP. The Chairman insisted that Ministry of Water Resource (MOWR) should provide und for taking up Feasibility study..

The Chairman of Expert Committee assured that they can provide fund for taking Feasibility study and asked our Chairman to give necessary letter for providing funds. This is indeed a good development in the right direction.

On the next day the Chairman had the opportunity to meet Mr.Sen, Expert Committee member and informed that he stressed that we must do something in the South as it is more affected by water scarcity and that there is no international problems. He also said that NWDA people knows that our NWP is better than theirs, but they are not accepting.

Many of our members felt that we must work on higher plane rather than that the name of the NGO and move towards achieving our goal of getting the project be implemented. Hence it was decided to form a corporate Company in the name of NAWAD TECH under sec 25.

This Company functions just like any other Corporate Company but with no profit no loss.

2.8.2009

The Principal Secretary of Bihar Government **Mr. Ajay Nayak** gave appointment to the Chairman to meet him on Aug.2nd 2009. Mr. Anil Hegde and Mr. Sekar accompanied during this visit. The Principle Secretary informed that they have decided to take up BWP.

Patna visit II (Bihar)

The Principal Secretary of Bihar Government Mr.Ajay Nayak gave appointment to the Chairman to meet him on Aug.2nd 2009. Since there was a sudden breach on river Bagmath on 1st morning, he had to rush to the spot and hence the meeting could not take place. The Chairman took this opportunity to go for a field visit in south Bihar.

We visited Sone River, about 50 km south of Patna. This river is about 1 Km wide and gets flood every year. BWP will intersect this river, harness the flood water, store and make it available to irrigation and drinking water for South Bihar. Mr.Anil Hegde and Mr. Sekar accompanied during this field visit.

Had the opportunity to meet PWD Engineers including the Chief Engineer. Also met the Former Chief Engineer and presently advisor to Government of Bihar Mr. Lal on 3rd August. The Principal Secretary Shri. Ajay Nayak gave appointment at 11 a.m on 4th August at his Chamber. Mr.Anil Hegde, Mr.Sekar and Mr.K.N.Lal Former Chief Engineer, advisor also joined in the meeting.

The Principal secretary informed that they have decided to take up BWP. He also said that they have decided to form a Committee with Chief Minister as a Chairman where A.C.Kamaraj Chairman, NAWAD Council and Mr.K.N.Lal will be advisors. It was proposed to take up Feasibility study by forming 7 divisions in PWD.

It was explained to Principal Secretary that BWP is a Unique and innovative project and that the T.E.F.S can be done more effectively only by NAWAD Council / NAWAD TECH as the members are well aware of the project. Further, this project is a Multidimensional one which can be implemented under B.O.O.T. Hence it was stressed that T.E.F.S should be done by NAWAD Council to give the proper path to move on the next step of implementation of project under B.O.O.T.
